President's Letter

Summer 2019

As everyone is getting back into their routines from our summer break, we have an event coming up next month that you can look forward to! Due to last year's success last year, we will again be bringing Oktoberfest to Sundial Park and our Annual Picnic. Join us on Sunday, October 20th from noon till 3pm. Details are in the newsletter and we welcome volunteer assistance before and after for setup and teardown.

In the last issue, I wrote about the State's legislative assault on Single Family Homes (zoned as RH-1 & RH-ID) and efforts in the City to oppose them. While the original SB50 bill has been sidelined, Senator Weiner has attempted to resurrect it by swapping out language in two other bills – SB330 Housing Crisis Act of 2019 and SB592 Housing Accountability Act. SB330 is especially dense and the Legislative Counsel Summary does not show its teeth. However, drilling down into the actual language, one finds where once again local zoning is invalidated under many conditions including that the land is simply "suitable or available for very low, low-, or moderate-income households in the jurisdiction's housing element, and consistent with the density specified in the housing element." In addition, the State is placing a large resource burden on any reductions or rejections of these secondary units by requiring that "it makes written findings, based upon a preponderance of the evidence in the record" of its decision. These are just some of the points. I have placed links to the bills on our website in the Community News section at www.ithasf.org.

I had also reported on my hope that this November's Housing Bond, now at \$600M, would address our senior housing issue on the Westside. Unfortunately, the monies allocated for seniors were mostly directed and very low-income projects. As many of you are aware, or will be, there is no housing for seniors who want to stay in their Westside neighborhoods but can no longer safely live in their current multi-story home. This fast growing class is typically equity-rich but cash-poor; however, even if they weren't, there does not exist senior-friendly housing with single-floor living, elevators, guest quarters, etc. that would allow these long-time residents to stay close to their friends. When I experienced this first-hand last year with my own parents, I needed to move them from their City home of 48 years, to Daly City in order to find independent senior living apartments. I have been working on a solution with Supervisor Yee, SF Planning, Joel Engardio, and

urban architect Eugene Low, which we plan to present at an upcoming ITHA Board meeting this Fall. It does not involve any up zoning or even changes to existing zoning but makes more efficient use of our existing transit corridors already zoned for multi-family units. Stay tuned...

While I am on the subject of neighborhood quality of life, I would like to address a disturbing trend that is also prevalent on the Westside and has moved into our urban park. No, I am not referring to coyotes. I am addressing the paving over/hardscaping of front yards for parking cars and boats. Even if it was not against City code to park in front setbacks (which it is), it dramatically undermines the curb appeal of our homes and in many cases is completely unnecessary in our neighborhood due to rear garages and long driveways. I realize there are those who want a low maintenance, watering-free front area. However, there are many examples of drought tolerant, light maintenance front yards in the area that can be emulated. In addition, we all know our sewer lines have little headroom, and removing required landscaping, increases run-off thereby reducing our capacity further. Please reach out to our Landscape committee, through John Stacy, if you are planning on redoing your front area for ideas. If you have already turned your front setbacks into parking pads, please reconsider, as you have not only negatively impacted the value of your property but your neighbor's as well.

Finally, it is great to see the young families that have been moving into the neighborhood. If you have joined us in the last year, please come to our annual picnic next month and introduce yourselves. I can guarantee you will not leave hungry and there will be plenty of activities for the kids.

Weed Abatements On Sidewalks

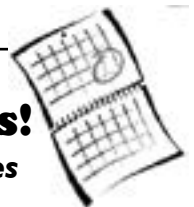

Pakwan Restaurant on Ocean is a Pakistani-Indian Delight

Even though Pakwan Restaurant on Ocean Avenue opened a couple of years ago, we only recently had the opportunity to sample their fare. We're happy to say that we weren't disappointed. Their food is fresh and delicious.

It's a little surprising to walk into the restaurant, because it's more like an "order at the counter, take a number, then sit down" kind of place. But don't be misled. The cheerful cashier who greeted us with a smile made us feel right at home.

We ordered the samosas (fried pastries with a potato and pea filling and spices) as an appetizer. They were perfectly cooked with a flaky pastry and moist filling. For one of us, they were a bit too spicy. (Alas, spiciness is in the eye of the beholder.) For entrees, we ordered the daal (yellow lentils cooked with turmeric and red chili) and the paneer wrap (chunks of cheese with onions, tikka masala sauce, and chutney wrapped in naan). The daal was probably the best daal dish we've ever had. The paneer wrap was a little unwieldy given the size of the naan, and although the onions could've used a little more time on the grill, the whole combination really worked well. We also ordered onion naan (round bread baked in a clay oven called a tandoor) to accompany our meal, and unlike other onion naans we've had, Pakwan loaded theirs up with lots of sweet and spiced onions. Finally, the mango lassi (mango pulp mixed with yogurt) was rich and creamy, like taking a bite out of a perfectly ripe mango.

Pakwan is a welcome addition to the burgeoning restaurant scene on Ocean Avenue, and we're tremendously happy to have them in our neighborhood. Pakwan Restaurant: 1140 Ocean Avenue; (415) 841-8400; www.pakwanrestaurant.com.
